- ★ A \$30 fee will be levied for all NSF cheques. Divers will not be allowed to participate until outstanding fees are paid in full.
- ★ In order to maintain a fun and safe environment for all divers, the head coach has full authority over all activities on the pool deck and at any dryland training programs offered by the FCDC. The coach has the right to discipline any diver, to remove any diver from the pool area and to suspend future diving privileges to ensure the safety of the diver or others. There will be no reduction in fees as a result of the removal or suspension of a diver.
- ★ There is an inherent risk of injury, both minor and serious, in the sport of diving, which injury may include damage to the head, neck, spine, muscles, internal or external organs; loss of or damage to sight, hearing or teeth; long or short-term disability; loss of income, career opportunities, or the enjoyment of life; pain; and scarring or disfigurement.
- ★ I waive any and all rights, claims, actions, causes of action, suits and demands (collectively, "Claims"), including which I ever had, now have or hereafter can, shall or may have, against FCDC (including its officers and directors) in connection with any injury or loss suffered by me in connection with my participation in the FCDC.
